

# SummerQuest 2012 Waiver & Release Form

**Payment and Cancellation:** I understand that a non-refundable deposit is required to register for SummerQuest and that payment is due in full on or before May 31. After May 31, I understand that full payment is due at the time of registration. Furthermore, I understand that a failure to comply with the aforementioned requirement will result in the termination of my registration and the forfeit of my deposit. I acknowledge that returned checks and/or insufficient funds will result in the assessment of a \$25.00 penalty on my account. I also understand that I have the right to a refund less the deposit when I cancel my registration more than two weeks in advance of the start of the session. I further acknowledge that within two weeks of the start of a session, I forfeit the right to a refund of any kind when I cancel. I also acknowledge that SummerQuest does not offer rebates for partial or incomplete attendance.

**Physical and Immunization Records:** I certify that I will provide The Trustees of Reservations with documentation of physical examination and immunization in accordance with MA Department of Public Health requirements for recreational camps at least one week prior to the start of the camp session. I understand that a failure to do so will result in my child not being able to attend camp.

**First Aid and Emergency Authorization:** I acknowledge that camp activities come with a risk of injury. I further understand that the staff is trained in basic emergency response. I hereby give permission to certified staff to provide routine first aid and CPR, to seek emergency medical treatment, and/or to arrange related transportation for my child, as necessary. I agree to hold The Trustees of Reservations harmless for any loss, damage or injury to person or property that may arise out of my child's participation in this program.

**Swimming Permission:** I give my child permission to go swimming at the Crane Estate. I understand that my child will be supervised by camp staff and certified lifeguards as required by law. I understand that my child will be swim tested each session, and may not be allowed to enter the water past his or her waist if he or she is unwilling or unable to pass the test.

**Photo Release:** I hereby give permission to The Trustees of Reservations to use my or my child's name and photographic likeness in any editorial and/or promotional material produced and/or published by TTOR in any form of printed or electronic media. I agree to contact The Trustees of Reservations in writing prior to the camp season if I choose not to allow my child's photo, name or likeness to be used. I hereby waive any right to inspect or approve the finished product in which my or my child's photographic likeness appears, or any copy that may be used

in connection with it, now or in the future. I waive any right to royalties or other compensation arising from, or related to, the use of any photographic likeness.

**Behavior Policy:** I understand that The Trustees of Reservations strives to create a safe, fun and supportive environment. Campers are introduced to the basic rules of behavior at SummerQuest on the first day of the session. Furthermore, I understand that if a situation should arise in which my child is unable to follow the rules, acts in a manner that makes it impossible for the group to function normally, or displays behavior that jeopardizes the health and safety of an individual or the camp as a whole, SummerQuest reserves the right to remove my child from the session and that I am entitled (upon request) to a refund for the days missed.
